Update by the Scientific Committee MB took note of the update and thanked to outgoing SC Chair Claire Dupont for her work and support over the last years.

SC Chair, Claire Dupont, summarised October meeting and retreat of SC, at which SC adopted opinion on EEA-Eionet evaluation; opinion on EEA recruitment and SC opinion on SPD 2025-2027. At the retreat SC members discussed Pact for Facts as one of the outcomes of MB/NFP/SC Seminar in June 2024; systemic perspectives and integration of knowledge across fields (One Health), opportunities of digitalisation and SOER 2025. SC Chair also highlighted the SC readiness to provide more value to MB in coming period. At last, the acting SC Chair, Mr Louis Meuleman, introduced himself to MB. Several MB members thanked the SC Chair, Claire Dupont, and outgoing SC members for their work and scientific support to EEA and MB.

#### FOR GUIDANCE - STRATEGIC ORIENTATION

MB response on EEA/Eionet evaluation 2017-2021

MB endorsed the Management Board response to EEA/Eionet evaluation 2017-2021 and asked the EEA to put in place an overview of actions needed to address the evaluation recommendations (action plan).

The MB Advisory Committee Chair summarised the work of the MBAC towards response to the evaluation. MBAC, taking into consideration feedback from MB and the opinion of the Scientific Committee, agreed response to EEA-Eionet evaluation. MB members praised the work of MBAC and welcomed the document. DG ENV reflected on the conclusion stating i) the EEA Regulation is fit for purpose though this is more open on future revision and new Commission might come back to this in a due course ii) Life funding was used to reinforce EEA budget to support new legislation; for future more robust system of financing is desirable and this shall be addressed under new MFF iii) methodology for evaluation is following Commission system of rules and better regulation guidelines, in future there is a need to strengthen the system of monitoring of EEA work. MB Chair highlighted the need for close cooperation between MB and DG ENV in ensuring adequate resources for EEA in future and invited MB members to liaise with their finance ministries on EEA financing in the context of next MFF

discussions.

Draft Action plan addressing recommendations of the MBAC response will be discussed in Bureau meeting in January 2025.	
7	Future of the EEA-Eionet Strategy (follow-up of the 12 June Stakeholder Seminar)	MB provided guidance on the process for the implementation of the EEA-Eionet Strategy in its second period (2026-2030), taking into consideration the outcomes of the EEA Stakeholder Seminar held on 12 June 2024 in Copenhagen, as well as the internal discussions with EEA staff on 24-26 September. MB agreed on the next steps, highlighting the need to consider the MB response to the EEA-Eionet evaluation. The discussion will follow at the March MB meeting with focus on digitalisation and cooperation with Western Balkan States and possible extension of EEA cooperation with Ukraine and Moldova.	item highlighting EEA MB/SC/NFP Seminar in June followed by EEA staff days in September 2024 and NFP/Eionet discussion in October and outlined the flow of the discussion in 2025. Several topics are emerging such as Digitalisation, Strengthening of Eionet and its enlargement. DG ENV thanked for the work and highlighted several priorities that shall feature in the midterm review - simplification, digitalisation, fine-tuning of existing activities and further alignment of publications with policy agenda.  The MB Chair suggested to discuss the process further in the Bureau including possibility to mandate one of the Vice-Chairs to follow the process more closely.  MB welcomed the process so far and highlighted several topics for EEA attention including EEA enlargement, strengthening of the communication and potential of digitalisation for easing reporting burden.

MB delegated the authority to the BU to confirm a final set of KPIs (Phase 1) at its meeting in January, while incorporating MB comments.	EEA introduced a proposal for revision of KPIs as an outcome of the Phase 1 and informed about the Phase 2 focusing on impact indicators. DG ENV stressed the importance of KPIs for evaluation of EEA work noting a good alignment of the current proposal with the EEA-Eionet Regulation and Strategy with more detailed feedback provided in writing. MB Chair invited MB members to provide written comments by 6 December and invited 1-2 MBs to support the Phase 2 working closely with the EEA.
